As more black and white police officers were arriving on the scene, another police officer came named Officer Thomas. He was walking up, when all of a sudden Det Torres came out of the house and said "got it." Got what I was thinking? I then said to Det. Torres to "Let me see it, I wanted to see the crack cocaine" since he was showing everything else he had found in the house. But once again Det. Torres refused to show me anything... why? Because he had set Antonio and me up!

Det. Torres supervisor Officer Johnson looked at me. I looked at him, he knew something was wrong. So he asked Det. Torres "Well is it enough for a conviction?" when Det. Torres said "Oh yeah, plenty more than enough." I asked Det. Torres again, to let me see the crack cocaine, but Det. Torres refused. First, it was the alleged search warrant, now it is the alleged crack cocaine. I did not see any of these two key important things they claimed to have. What was really going on?

Det. Torres, then hurried up and went over to my boyfriend Antonio and he started reading him his Miranda Rights, when I said to him "Why are you reading him his rights for, he doesn't live here?" Det. Torres just held out his hand to silence me and said "Hold on wait a minute" and he continued to read him his rights anyway. I knew something was wrong because of the way Det. Torres rushed over to my boyfriend Antonio to read him his rights.

You see Det. Torres had to hurry up and get his crew out of there because.....

1. They had no search warrant and they were there as a favor to help Ms. Jackson out and E95822 because he is a married man and was having an affair and it was on the radio that a Police Officer was hurt so they had to make an arrest so they could lock up my house and leave the crime scene before the Captain and everyone else started to arrive on the scene.

As the other black and white Police Officers were arriving upon the scene, another female police officer came named Officer Cook who entered into the two unit duplex. She escorted me back into my house and into the bedroom were she told me to turn around. She then took the handcuffs off of me, and she told me to put some clothes on and after I got dress she took me back outside my house and put me in a police car without anyone ever reading me, my Miranda Rights! What is the law?



What kind of world do we live in when people only care for themselves and cover up for the people who have committed murder and sabotaged in this case among other things and let them go free?

Judge James Sharp said it best. "How do we expect for individuals to follow the rules when the City Employees aren't following them?" The object of the law is to protect the legal rights of all human beings."

After this incident happened I contacted the Internal Affairs on September 23, 1999 and filed an Employee Misconduct Complaint with them at the Wilshire Police Station, and right after I filed this complaint with the Internal Affairs, I guess when I picked Officer Monarek and Officer Cathy Lopes out through their line up, a hit was put on me. Who at the Wilshire Police Station told that I had ID them? Was it another Los Angeles Police Officer? Who is a part of this Organize Crime Ring? How did they know? Did someone tell them misleading information about me that would want them to try to kill me or someone else to come after me for no reason? I WOULD REALLY LIKE TO KNOW?

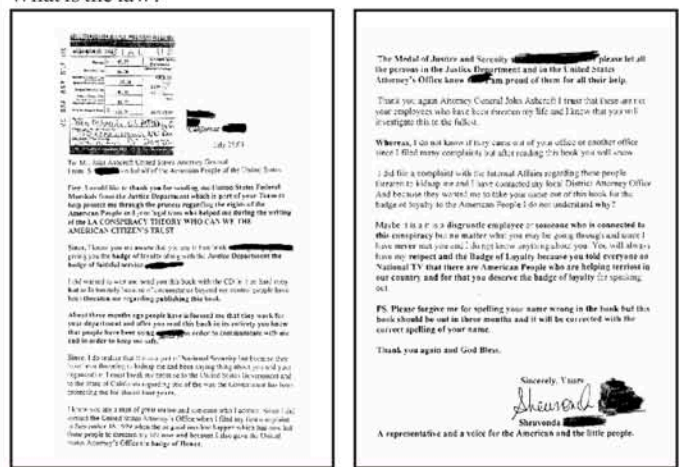

My son has been through four trials. Three of the trials returned with a hung jury. The fourth trial returned with a guilty verdict.

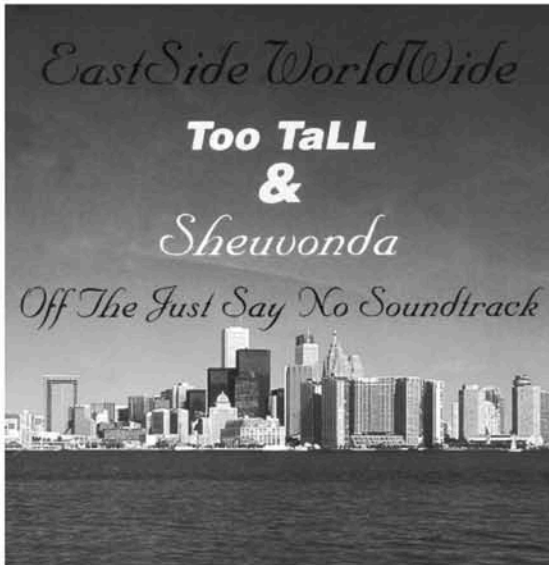
